New policy: Visitors

In addition to our new policy on Exeats we have had to introduce a new policy on visitors to the school. In order to protect our learners, we have to control any and all visitors to the campus. That includes any and all adults who are not employees of the school, which I am afraid includes all our parents and other relatives of learners.

The new Visitors Policy can also be found on the General Information page of our website.

Please therefore note that from Monday, 05 February 2024 there are new protocols concerning visiting the school. In brief:

- All visitors including all parents of learners from grade 1 to 12: are required to park outside the admin block and report to reception in the Admin Block.
- All parents of Squirrels Nest learners: are to park outside the SN block and report to reception there for further assistance.

Although this may involve a little more inconvenience for some, we have decided it is no longer in the interests of our learners' safety to have unaccompanied adults wandering about the school. I do beg your understanding in this regard.

Debating

Some good news from Mr. Tlou Mashitisho, a teacher in charge of debating, from a letter he wrote to me and Mr. Goeminne.

"Thank you for supporting the debating activities in Polokwane since 2016. There are only two schools in the city that can claim to be the home of debating ... Children who participate in the coaching programme go on to represent the province (and their schools) at the national championship.

"Additionally, the school has made the school bus available ... (which) has made coordinating the trip so much easier ... All this support is not in vain.

"At the last championship (hosted in Kimberley), the learners performed exceptionally well. Two of our learners from Mitchell House were a part of the delegation. Of the 7 teams that participated, 6 made it into the break rounds for their respective competitions. One of the senior teams (Mabetji Mankga was on that team) made it to the semifinal of the Senior Open division and one of the junior teams made it to the final in

the Junior Open division (for the first time in 14 years). The Open division is the highest division at the championship.

"This means that learners from our local schools are able to debate competitively against some of South Africa's most elite speakers from the country's most elite schools ... This is such a tremendous achievement

Which of course I think makes us one of those top schools!!

In a thrilling kick-off to the term, Ironwood (Prep school) and Independent schools (College) showcased exceptional athletic ability across the school. New policy: Exeats (first posted, 19 January 2024)

Please note we have had to adopt a new policy regarding parents taking their children out of the school during the school day. There have been a number of situations where children have been taken by parents without the knowledge of the school, causing some unnecessary consternation. The new policy is called the Exeat Policy and can be found on the General Information page of our website.

An Exeat is formal permission from the school for the temporary absence of a learner without staff supervision, from campus or any school activity or outing. The rules governing Exeats are taken very seriously by the School due to the safety concerns of the learners. According to the Contract of Enrolment, the school is responsible for all learners during the course of the school day. It follows there is a formal process to be followed by both parties to the contract (parents and school) when a learner is required to





leave school during the school day. It is equally important such protocols are followed regarding Exeats by boarders.

School Counsellor (first posted, 19 January 2024)

From the start of 2024 the School Counsellor. Ms. Sumayya Cachalia will be working full-time at the school. We are very pleased to be able to extend this service. Ms. Cachalia will still do some teaching of Life Orientation in the College with the remainder of her time being available for consultations.

Ms. Cachalia is a registered Social Worker and her work at the school is governed to a large extent by the regulatory framework governing Social Workers in South Africa. To ensure that the school and all who interact with her comply, we have drawn up a Policy and referral form which is published on the General Information page of the school website.

Memorandum of Incorporation (MOI): proposed amendments (first posted, 24 November 2023)

In terms of Clause 3.16.1. notice if hereby given of the intention to amend the MOI at the Annual General Meeting of the parents to commence at 17h30 on 16 April 2024.

Clause 3.16.1 reads as follows:

"The Memorandum of Incorporation may only be amended or modified at a meeting of the Parents of which at least twenty-one (21) days written notice has been given to all the Parents, and at which meeting seventy five percent (75%) of the total number present vote in favour thereof"

The Board of Governors has been in the process of reviewing the MOI throughout the year and at its last meeting (14 November 2023) approved the amendments to be proposed to the AGM. Such a review was last done in 2014. The proposed amendments update the MOI ensuring it is fit for purpose as the supreme governing instrument for the school.

The current MOI and proposed new version is published and available for review at reception. Included is a version that tracks all the proposed changes. Any comments are to be addressed by email to principal@mitchellhouse.co.za

Please note that from September 2023, I have published the information regarding the channels of communication below, in every newsletter, so that it is easy for parents to find.

We have now developed a formal policy on communication, which explains what is contained below in a bit more detail. It governs all our communications at the school. We have done some training with the staff on this and now publish the policy on the General Information page of our website for your information. Communication is the oil that keeps the school running smoothly. Please can I encourage all our stakeholders, Parents, Staff and Learners to use the channels correctly.

Highlights from the policy:





We use many different forms of communication at the school:

- The Website: important information is published either on the Prep School, College, or Boarding pages. The General Information page also carries important information. It is well-worth spending ten minutes having a look around.
- Social media platforms are used more for publicity and advertising for the school.
- Our Whats App groups throughout the school is increasingly becoming the most important immediate form of communication.
- Regular newsletters.
- Email still tends to be used as a more formal form of communication.

The above platforms are available for more general forms of communication.

Parents will also want to raise a particular issue affecting their own child. In that regard it is important that such matters are raised with the responsible person. For everything concerning your child your first port of call is to make an appointment to see the relevant teacher (class or subject teacher) or sport coach. Also please make the effort to make an appointment. Don't try and deal with the matter on the side of the field or in the corridor when you come to collect your child. The teacher/coach may not be available and won't be prepared. If the matter is important enough, then it is important to be able to sit down together in private to discuss your child.

If you are not happy after a discussion with a teacher / coach, then by all means escalate the matter to the relevant line manager in the phase:

If you do have a question, especially if you think it will be of interest to others, please drop me and email and I will publish the query and my reply in a future newsletter. I have used that as a form of communication very effectively in the other schools I have worked at. I will carry a reminder of same in every newsletter from now on.
